Dear Sir/Madam,

As you are aware, para B(8)(iii) of chapter 2 of the Compendium of guidelines regarding Board level appointments in Central Public Sector Enterprises dated 29.08.2017 inter alia provides that:

Sectoral candidate is one who is an employee of those CPSEs which fall in the same cognate group as per DPE guidelines issued from time to time.

2. The DPE on its website under the head "Public Enterprises Survey 2015-16" has provided inter alia a list of CPSEs under different sectors/cognate groups. Based on this list, the PESB has hosted on its website a list of only those CPSEs which are participating in the PESB process for the purpose of determination and shortlisting of sectoral candidate as provided in para 1 above.

3. Recently, the DPE approved a change of the cognate group of Central Warehousing Corporation and Central Railside Warehouse Corporation and decided to reflect/update the re-grouping of these CPSEs in their next PE Survey 2016-17. Keeping in view the implications of any such change of cognate group on advertisement of vacancies and eligibility of candidates especially with regard to para 1 above, the Board of the PESB discussed the matter at length, especially the impact of revision of cognate group list, and its updation on the website of DPE and PESB, the date from which any such change would become effective and its application on shortlisting of candidates etc. and took the following decisions:

(i) PESB should be informed about any changes/updation in the Cognate group list as soon as the decision is taken and the same also be revised on the website of DPE;

(ii) PESB would also reflect the change in the Cognate group on its website soon after receipt of intimation from DPE;

(iii) the revised/updated list of cognate group will become effective from the date the same is uploaded on the website of PESB. However, in cases where posts have already been advertised and change in cognate group has been effected subsequently, candidates will be shortlisted as per the list of cognate group that existed at the time of advertisement of the post.

4. All Ministries/Departments are requested to kindly make a note of the above and suitably advice CPSE under their administrative jurisdiction.
