I. COMPANY PROFILE

Engineers India Limited (EIL) was established under Indian Companies Act, 1956 with the objective for providing design, engineering and related project management and consultancy services for setting up hydrocarbon and processing industry plants in the country. EIL's corporate vision is "to be a world class globally competitive EPC and total solutions Consultancy Organisation." EIL is a schedule 'A' / Nav-Ratna CPSE in the Industrial Development and Technical Consultancy Services sector under the administrative control of Ministry of Petroleum & Natural Gas. Its Registered and Corporate offices are in New Delhi.

The authorized and paid up capital of the Company was Rs. 300 crore and Rs.168.47 crore respectively as on March 31, 2016.

The shareholding of the Government of India in the company is 69.37%.

II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Technical) is a member of the Board of Directors and reports to Chairman and Managing Director. He is responsible for identifying process technologies, which could be of interest to EIL in future, and plan and coordinate research, design and development activities in those fields as well as collaboration where necessary.

- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.
