I. COMPANY PROFILE

Grid Controller of India Limited (GRID-INDIA) formerly known as Power System Operation Corporation Limited (POSOCO), is wholly owned Government of India Company w.e.f. 3rd January 2017 with the mission to "Ensure Integrated Operation of the India Power System to facilitate transfer of electric power within and across the regions and trans-national exchange of power with Reliability, Economy and Sustainability" and "Facilitate competitive and efficient wholesale electricity markets and administer settlement systems".

GRID-INDIA has been entrusted with the responsibility of operating the National Load Despatch Centre (NLDC) and the five Regional Load Despatch Centre (RLDCs) w.e.f. 1st October, 2010. GRID-INDIA has since been discharging the statutory function of power system operation under the Electricity Act 2003, GIRD-INDIA is discharging functions as per the Regulations/Standards laid down by central Electricity Regulatory Commission (CERC) under the Act.

Its Registered office is at B-9, Qutab Institutional Area, Katwaria Sarai, New Delhi.

The company employed 643 regular employees (Executives : 577 & Non-Executives: 66) as on 31.03.2023.

The authorized and paid up capital of the Company are Rs. 200 crores and Rs. 30.64 crores respectively as on 31.03.2023.

The shareholding of the Government of India in the company is 100% as on 31.03.2023.

II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Market Operation) is a member of the Board of Directors and reports to the Chairman and Managing Director. He/She is responsible for the commercial operations, electricity market operations, open access in inter-state transmission, Power Exchange operations, Accounting and settlement of electricity transmitted through the grid, deviation settlement, pool account operations, integration of renewable energy, REC mechanism, and legal and regulatory affairs.

III. ELIGIBILITY

2. EMPLOYMENT STATUS:

3. QUALIFICATION:

The applicant should be an Engineering Graduate from a recognized University/ Institution with good academic record. Applicants holding MBA/ Post Graduate Diploma in Management or post graduate in economics will have added advantage.

4. EXPERIENCE:

The applicant should have at least 5 years of cumulative experience during the last 10 years in Power Market Operation or Power system operation in an organization.

3. For candidates from SPSE/ Private Sector

- a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.
