### I. COMPANY PROFILE

Braithwaite and Co. Limited (BCL) was incorporated on 01.12.1976 when the assets acquired by the Government of India under "Braithwaite and Company (India) Limited (Acquisition and Transfer of Undertakings) Act, 1976" were vested with BCL after its takeover by the Government. Presently, BCL is a schedule-"B", 'Miniratna–I Category' CPSE in Heavy Engineering Sector under the Administrative control of M/o Railways.

BCL has its registered and corporate offices at Kolkata, West Bengal.

The company employed 184 regular employees (Executives: 46, Non Executives: 138) as on 31.03.2022.

The authorized and paid up share capital of the company is Rs.2000 crores and Rs. 83.42 crores respectively as on 31.03.2022.

The shareholding of Government of India in the company is 100% as on 31.03.2022.

# **II. JOB DESCRIPTION AND RESPONSIBILITIES**

The Chairman & Managing Director is the Chief Executive of the Corporation and accountable to its Board of Directors and Government/Share holders. He is responsible for the efficient functioning of the Corporation for achieving the corporate objectives and performance parameters.

### III. ELIGIBILITY
