## I. COMPANY PROFILE

Brahmaputra Cracker and Polymer Limited (BCPL) was incorporated under the Companies Act, 1956 with the objective to engage in the construction and operation of a greenfield Petrochemical Plant in Lepetkata, Distt. Dibrugarh, Assam. The plant was successfully commissioned on 2nd January, 2016 and dedicated to the nation on 5th February, 2016.

GAIL (India) Limited is the main promoter having 70% of equity participation and the rest 30% is equally shared by Oil India Ltd.(OIL), Numaligarh Refinery Limited(NRL) and Government of Assam.

BCPL is a Schedule 'B' CPSE with the administrative jurisdiction of Department of Chemicals & Petrochemicals, Minisry of Chemicals & Fertilizers.

Its registered office is at Guwahati, Assam.

The Authorised Share Capital and Paid up capital of the Company was Rs. 2000 crore and Rs. 1402.80 crore respectively as on March 31, 2018.

The company employed 620 regular employees [Executives 428, Non-executives 192] as on 31.03.2018. Further, 34 executives were on secondment from GAIL(India) Ltd.

## II. JOB DESCRIPTION AND RESPONSIBILITIES

Managing Director is the Chief Executive of the Company and is accountable to the Board of Directors and Government/ Share holders. He/She is responsible for the efficient functioning of the Company and for achieving its corporate objectives and performance parameters

## III. ELIGIBILITY

**1. AGE :** On the date of occurrence of vacancy (DOV)

**2. EMPLOYMENT STATUS:**

The applicant must, on the date of application, as well as on the date of interview, be employed in a regular capacity – and **not** in a contractual/ad-hoc capacity – in one of the followings:-

(a) Central Public Sector Enterprise (CPSE) (including a full-time functional Director in the Board of a CPSE);

(b) Central Government including the Armed Forces of the Union and All India Services;

(c) State Public Sector Enterprise (SPSE) where the annual turnover is **\*Rs 1500 crore or more**;

(d) Private Sector in company where the annual turnover is **\*Rs 1500 crore or more**.

**Preference would be given to candidates from listed Companies.**

*(\* The average audited annual turnover of three financial years preceding the calendar year in which the post is advertised shall be considered for applying the approved limits)*

**3. QUALIFICATION:**

The applicant should be a graduate with good academic record from a recognised University/Institute.

Applicants with Technical/MBA qualifications will have added advantage.

**4. EXPERIENCE:**

Applicants should possess adequate experience at a senior level of management in an organisation of repute.

Applicants with experience in Finance/Marketing/Production will have added advantage.

Experience in Petroleum/Gas/Chemicals/ Fertilizer Sector is desirable.

**5. PAY SCALE/ RANK/ LEVEL:**

**The minimum length of service required in the eligible scale/rank/level will be one year for internal candidates, and two years for others as on the date of vacancy.**

**(i) Applicants from Central Govt. / All India Services** should be holding a post of the level of Joint Secretary in Govt. of India or carrying equivalent scale of pay.

**(ii) Applicants from the Armed forces of the Union** should be holding a post of the level of Major General in the Army or equivalent rank in Navy/Air Force.

**Applicants from State Public Sector Enterprises/ Private Sector** should be working at Board level position.

#### **6. CONDITION OF IMMEDIATE ABSORPTION FOR CENTRAL GOVERNMENT OFFICERS**

Central Government Officers, including those of the Armed Forces of the Union and the All India Services, will be eligible for consideration only on immediate absorption basis.

#### **IV. DURATION OF APPOINTMENT**

The appointment shall be for a period of five years from the date of joining or upto the date of superannuation or until further orders, whichever is earlier.

#### **V. SUBMISSION OF APPLICATIONS**

All applicants should send their applications as per the format .

1. The applicants should submit their applications through proper channel as follows:

(a) Government Officers, including those of the Armed Forces of the Union and All India Services: through Cadre Controlling authority;

(b) CMDs/MDs/Functional Directors in CPSE: through the concerned Administrative Ministry;

(c) Below Board level in CPSE: through the concerned CPSE;

(d) CMDs/MDs/Functional Directors in State PSE: through the concerned Administrative Secretary and Cadre Controlling Authority, if any, of the State Government;

(e) Private Sector: directly to the PESB.

2. Applicants from Private Sector must submit the following documents along with the application form:

(a) Annual Reports of the Company in which currently working for the 3 financial years preceding the calendar year in which the post is advertised (please provide URL or attach/enclose copies);

(b) Whether the company is listed or not; if yes, the documentary proof (please provide URL or attach/enclose copies);

(c) Evidence of working at Board level;

(d) Self-attested copies of documents in support of age and qualifications;

(e) Relevant Jobs handled in the past with details.

#### **VI. UNDERTAKING BY THE APPLICANT**

An applicant has to give an undertaking as a part of the application that he/she will join the post, if selected. If an applicant does not give such undertaking, the application would be rejected.

**1. For candidates from Central Government/Armed Forces of the Union/ All India Services**

(a) The appointment is on immediate absorption basis.

(b) If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.

(c) Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.

## **2. For candidates from CPSE**

a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

## **3. For candidates from SPSE/ Private Sector**

a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.

b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.

4. In the above cases, no request for relaxation or otherwise would be entertained.
