**I. COMPANY PROFILE**

The Brahmaputra Valley Fertilizer Corporation Limited (BVFCL) was incorporated in 2002 under the Indian Companies Act 1956 with the objective to de-merge the Namrup I, II and III plants from Hindustan Fertilizer Corporation Ltd. It is one of the enterprises engaged in the production of Urea fertilizer. BVFCL is a CPSE in fertilizer sector with the administrative jurisdiction of Department of Fertilizers, Ministry of Chemical and Fertilizers. The company employed 595 regular employees (Executives- 415 & Non-Executives- 180) as on 31.3.2019.

Its Registered and Corporate offices are at Namrup, Assam.

The authorised share and paid up capital of the Company was Rs. 510 crore and Rs.365.83 crore respectively as on March 31, 2019.

The shareholding of the Government of India in the Company is 100%.

**II. JOB DESCRIPTION AND RESPONSIBILITIES**

Director (Production) is a member of Board of Directors and reports to Chairman and Managing Director. He/She acts as the head of the Production/Operations Division of the Company. His/Her principal responsibility is to exercise control for the efficient operations of the plants of the Company in a manner which would ensure optimum utilization of resources. He/She also acts as Principal Adviser of the Company in all production and operational matters.

**III. ELIGIBILITY**

**1. AGE :** On the date of occurrence of vacancy (DOV)

**2. EMPLOYMENT STATUS:**

The applicant must, on the date of application, as well as on the date of interview, be employed in a regular capacity – and **not** in a contractual/ad-hoc capacity – in one of the followings:-

(a) Central Public Sector Enterprise (CPSE) (including a full-time functional Director in the Board of a CPSE);

(b) Central Government including the Armed Forces of the Union and All India Services;

(c) State Public Sector Enterprise (SPSE) where the annual turnover is **\*Rs 750 crore or more**;

(d) Private Sector in company where the annual turnover is **\*Rs 750 crore or more**.

**Preference would be given to candidates from listed companies.**

*(\* The average audited annual turnover of three financial years preceding the calendar year in which the post is advertised shall be considered for applying the approved limits)*

**3. QUALIFICATION:**

The applicant should be an Engineering graduate with good academic record from a recognized University/Institution.

Applicants holding MBA/Post Graduate Diploma in management will have an added advantage.

**4. EXPERIENCE:**

The applicant should possess adequate technical/operational experience at a senior level in a large organization of repute, out of which at least two years during the last ten years should have been in major production units in Fertilizers/ Chemicals/ petrochemicals sector.

**5. PAY SCALE:**

**The minimum length of service required in the eligible scale will be one year for internal candidates, and two years for others as on the date of vacancy.**

**(i) Applicants from Central Government / All India Services** should be holding a post of the level of Director in Government of India or carrying equivalent scale of pay on the date of application.

**(ii) Applicants from the Armed forces of the Union** should be holding a post of the level of Brigadier in the Army or equivalent rank in Navy/Air Force on the date of application.

**Applicants from State Public Sector Enterprises/ Private Sector** should be working at Board level position or at least a post of the level immediately below the Board level on the date of application.

#### **6. CONDITION OF IMMEDIATE ABSORPTION FOR CENTRAL GOVERNMENT OFFICERS**

Central Government Officers, including those of the Armed Forces of the Union and the All India Services, will be eligible for consideration only on immediate absorption basis.

#### **IV. DURATION OF APPOINTMENT**

The appointment shall be for a period of five years from the date of joining or upto the date of superannuation or until further orders, whichever is earlier.

#### **V. SUBMISSION OF APPLICATIONS**

All applicants should send their applications as per the format .

1. The applicants should submit their applications through proper channel as follows:

- (a) Government Officers, including those of the Armed Forces of the Union and All India Services: through Cadre Controlling authority;
- (b) CMDs/MDs/Functional Directors in CPSE: through the concerned Administrative Ministry;
- (c) Below Board level in CPSE: through the concerned CPSE;
- (d) CMDs/MDs/Functional Directors in State PSE: through the concerned Administrative Secretary and Cadre Controlling Authority, if any, of the State Government;
- (e) Below Board level in SPSE: through the concerned SPSE.
- (f) Private Sector: directly to the PESB.

2. Applicants from Private Sector must submit the following documents along with the application form:

- (a) Annual Reports of the Company in which currently working for the 3 financial years preceding the calendar year in which the post is advertised (**please provide URL or attach/enclose copies**);
- (b) Whether the company is listed or not; if yes, the documentary proof (**please provide URL or attach/enclose copies**);
- (c) Evidence of working at Board level or at least a post of the level immediately below the Board level;
- (d) Self-attested copies of documents in support of age and qualifications;
- (e) Relevant Jobs handled in the past with details.

#### **VI. UNDERTAKING BY THE APPLICANT**

An applicant has to give an undertaking as a part of the application that he/she will join the post, if selected. If an applicant does not give such undertaking, the application would be rejected.

**1. For candidates from Central Government/Armed Forces of the Union/ All India Services**

(a) The appointment is on immediate absorption basis.

(b) If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.

(c) Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.

**2. For candidates from CPSE**

a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

**3. For candidates from SPSE/ Private Sector**

a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.

b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.

**4.** In the above cases, no request for relaxation or otherwise would be entertained.
