**I. COMPANY PROFILE**

Hindustan Copper Limited (HCL) was incorporated in 1967 under the Indian Companies Act, 1956. The main objective of the company is exploration, mining, beneficiation of copper ore, smelting and refining and processing of downstream products. The company has copper mines at Malanjkhand in Madhya Pradesh, Khetri (Rajasthan), Ghatsila(Jharkhand). It has smelters at Ghatsila (Jharkhand) and at Jhagadia(Gujarat) and a Continuous Cast Copper Wire Rod plant at Taloja(Maharashtra). HCL is a schedule –'A'/Miniratna PSE with the administrative jurisdiction of Ministry of Mines.

The Company employed 2195 regular employees (Executives: 598 & Non-Executives: 1597) as on 31.03.2019.

Its Registered and Corporate offices are in Kolkata, West Bengal.

The authorised and paid up capital of the Company was Rs.1100 crores and Rs.462.61 crores respectively as on 31.03.2019.

The shareholding of the Government of India in the company is 76.05%.

**II. JOB DESCRIPTION AND RESPONSIBILITIES**

Director (Operations) is a member on the Board of Directors and reports to the Chairman and Managing Director. He/ She heads the operations of copper smelting and refining plants. In addition, he/she is also in charge of project management and execution of various mine projects

with emphasis on contract administration.

### III. ELIGIBILITY

#### 2. EMPLOYMENT STATUS:

The applicant must, on the date of application, as well as on the date of interview, be employed in a regular capacity – and **not** in a contractual/ad-hoc capacity – in one of the followings:-

- Central Public Sector Enterprise (CPSE) (including a full-time functional Director in the Board of a CPSE);
- Central Government including the Armed Forces of the Union and All India Services;
- State Public Sector Enterprise (SPSE) where the annual turnover is **\*Rs 2000 crore or more**;
- Private Sector in company where the annual turnover is **\*Rs 2000 crore or more**.

**Preference would be given to candidates from listed companies.**

*(\* The average audited annual turnover of three financial years preceding the calendar year in which the post is advertised shall be considered for applying the approved limits)*

#### 3. QUALIFICATION:

The applicant should be an Engineering graduate preferably in Mining/Metallurgy/Mechanical/Electrical with good academic record from a recognised University/ Institution.

Applicants with MBA qualification will have added advantage.

#### 4. EXPERIENCE:

The applicant should possess at least five years' technical/operational/project experience during the last ten years at a senior level of management in the mining/metal sector.

Persons with experience of dealing with underground mine projects and related fields would have added advantage.

#### 5. PAY SCALE:

**(ii) Applicants from the Armed forces of the Union** should be holding a post of the level of Major General in the Army or equivalent rank in Navy/Air Force on the date of application.

**Applicants from State Public Sector Enterprises/ Private Sector** should be working at Board level position or at least a post of the level immediately below the Board level on the date of application.

**6. CONDITION OF IMMEDIATE ABSORPTION FOR CENTRAL GOVERNMENT OFFICERS**

Central Government Officers, including those of the Armed Forces of the Union and the All India Services, will be eligible for consideration only on immediate absorption basis.

**IV. DURATION OF APPOINTMENT**

The appointment shall be for a period of five years from the date of joining or upto the date of superannuation or until further orders, whichever is earlier.

**V. SUBMISSION OF APPLICATIONS**

All applicants should send their applications as per the format .

- (d) CMDs/MDs/Functional Directors in State PSE: through the concerned Administrative Secretary and Cadre Controlling Authority, if any, of the State Government;
- (e) Below Board level in SPSE: through the concerned SPSE;
- (f) Private Sector: directly to the PESB.

2. Applicants from Private Sector must submit the following documents along with the application form:

- (a) Annual Reports of the Company in which currently working for the 3 financial years preceding the calendar year in which the post is advertised (**please provide URL or attach/enclose copies**);
- (b) Whether the company is listed or not; if yes, documentary proof (**please provide URL or**

**attach/enclose copies);**

- (c) Evidence of working at Board level or at least a post of the level immediately below the Board level;
- (d) Self-attested copies of documents in support of age and qualifications;
- (e) The relevant Jobs handled in the past with details.

## **VI. UNDERTAKING BY THE APPLICANT**

An applicant has to give an undertaking as a part of the application that he/she will join the post, if selected. If an applicant does not give such undertaking, the application would be rejected.

### **1. For candidates from Central Government/Armed Forces of the Union/ All India Services**

- (a) The appointment is on immediate absorption basis.
- (b) If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.
- (c) Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.

### **2. For candidates from CPSE**

- a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.
- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

### **3. For candidates from SPSE/ Private Sector**

- a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.
- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.

- 4. In the above cases, no request for relaxation or otherwise would be entertained.
