## I. COMPANY PROFILE

Garden Reach Workshop Limited was taken over by the Government of India in 1960. The Company was renamed as Garden Reach Shipbuilders and Engineers Limited (GRSE) in 1977 due to its diversified product range as a result of rapid diversification, through taking over of a number of sick engineering units. The primary objective of the Company is to construct warships and auxiliary vessels for the Navy and the Coast Guard. GRSE has seven units in and around Kolkata and a Diesel Engine plant at Ranchi. GRSE is a Schedule ' B' / Miniratna with the administrative jurisdiction of D/o Defence Production, Ministry of Defence.

Its Registered and Corporate Offices is in Kolkata, West Bengal.

The company employed 1900 regular employees (Executives: 488, Non-executives:1412) as on 31.03.2021.

The authorized and paid up capital of the Company was Rs. 125 crores and Rs. 114.55 crores respectively as on 31.03.2021.

The shareholding of the Government of India in the Company is 74.50% as on 31.03.2021.

## II. JOB DESCRIPTION AND RESPONSIBILITIES

The Chairman and Managing Director is the Chief Executive of the Company and accountable to its Board of Directors and Government/ Share holders. He/She is responsible for the efficient functioning of the Company, and for achieving its corporate objectives and performance

parameters, promoting indigenisation under Atma Nirbhar Scheme of the Government.

### III. ELIGIBILITY

#### 2. EMPLOYMENT STATUS:

The applicant must, on the date of application, as well as on the date of interview, be employed in a regular capacity – and **not** in a contractual/ad-hoc capacity – in one of the followings:-

- (a) Central Public Sector Enterprise (CPSE) (including a full-time functional Director in the Board of a CPSE);
- (b) Central Government including the Armed Forces of the Union and All India Services;
- (c) State Public Sector Enterprise (SPSE) where the annual turnover is **\*Rs 1000 crore or more**;
- (d) Private Sector in company where the annual turnover is **\*Rs 1000 crore or more**.

**Preference would be given to candidates from listed Companies.**

*(\* The average audited annual turnover of three financial years preceding the calendar year in which the post is advertised shall be considered for applying the approved limits)*

#### 3. QUALIFICATION:

The applicant should be an Engineering graduate/Chartered Accountant/Cost Accountant/graduate with full time MBA/PGDIM from leading institute.

#### 4. EXPERIENCE:

Applicants should possess adequate experience at a senior level of management in an organisation of repute.

Experience in Shipbuilding/Repairs/Design is desirable.

#### 5. PAY SCALE:

#### **6. CONDITION OF IMMEDIATE ABSORPTION FOR CENTRAL GOVERNMENT OFFICERS**

Central Government Officers, including those of the Armed Forces of the Union and the All India Services, will be eligible for consideration only on immediate absorption basis.

#### **IV. DURATION OF APPOINTMENT**

The appointment shall be for a period of five years from the date of joining or upto the date of superannuation or until further orders, whichever is earlier.

#### **V. SUBMISSION OF APPLICATIONS**

1. The applicants should submit their applications through proper channel as follows:

(d) CMDs/MDs/Functional Directors in State PSE: through the concerned Administrative Secretary and Cadre Controlling Authority, if any, of the State Government;

(e) Private Sector: directly to the PESB.

2. Applicants from Private Sector must submit the following documents along with the application form:

**(a) Annual Reports of the Company in which currently working for the 3 financial years preceding the calendar year in which the post is advertised (please provide URL or attach/enclose copies);**

**(b) Whether the company is listed or not; if yes, the documentary proof (please provide URL or attach/enclose copies);**

(c) Evidence of working at Board level.

(d) Self-attested copies of documents in support of age and qualifications;

(e) Relevant Jobs handled in the past with details.

## **VI. UNDERTAKING BY THE APPLICANT**

An applicant has to give an undertaking as a part of the application that he/she will join the post, if selected. If an applicant does not give such undertaking, the application would be rejected.

### **1. For candidates from Central Government/Armed Forces of the Union/ All India Services**

(a) The appointment is on immediate absorption basis.

(b) If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.

(c) Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.

### **2. For candidates from CPSE**

a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

### **3. For candidates from SPSE/ Private Sector**

a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.

b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.

4. In the above cases, no request for relaxation or otherwise would be entertained.
