I. COMPANY PROFILE

HLL Lifecare Limited(formerly Hindustan Latex Limited),(HLL) was established in the year 1966 as a Public Sector Enterprise under the Companies Act, 1956. It is one of the largest Contraceptive manufacturers and health care and consumer products marketing organization reaching out to the urban centres as well as rural centres. HLL is a Schedule 'B' Miniratna CPSE in the Consumer Goods sector with the administrative jurisdiction of Ministry of Health and Family Welfare. The company employed 1413 regular employees (Executives & Non-Executives) as on 31.03.2021.

Its Registered and Corporate Office are at Thiruvananthapuram in Kerala.

The authorized and paid up capital of the Corporation is Rs. 300 crores and Rs.15.53 crores respectively as on 31.03.2021.

The shareholding of the Government of India in the company is 100%.

The Cabinet Committee on Economic Affairs (CCEA), Government of India, in its meeting held on 1st November 2017 has granted 'in-principle' approval for sale of 100% of Government's equity in HLL via a two-stage auction process.

II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Technical & Operations) is a member of the Board of Directors and reports to the Chairman and Managing Director. He/ she is expected to provide the Board inputs on technical and production aspects concerning the entire manufacturing range of the Company and is

responsible for the company's development of production processes, improving production infrastructure, research, updating the existing technology, identifying new technologies and also assisting the future growth of the company in accordance with its corporate plan.

III. ELIGIBILITY

2. EMPLOYMENT STATUS:

The applicant must, on the date of application, as well as on the date of interview, be employed in a regular capacity – and **not** in a contractual/ad-hoc capacity – in one of the followings:-

- (a) Central Public Sector Enterprise (CPSE) (including a full-time functional Director in the Board of a CPSE);
- (b) Central Government including the Armed Forces of the Union and All India Services;
- (c) State Public Sector Enterprise (SPSE) where the annual turnover is ***Rs 10000 crore or more**;
- (d) Private Sector in company where the annual turnover is ***Rs 10000 crore or more**.

Preference would be given to candidates from listed Companies.

(The average audited annual turnover of three financial years preceding the calendar year in which the post is advertised shall be considered for applying the approved limits)*

3. QUALIFICATION:

The applicant should be an engineering graduate or equivalent with good academic record from a recognized University/ Institution.

4. EXPERIENCE:

The applicant should have adequate technical/ operational experience at a senior level in an organization of repute, out of which at least five years during the last ten years should have in manufacturing sector.

5. PAY SCALE:

The minimum length of service required in the eligible scale will be one year for internal candidates, and two years for others as on the date of vacancy.

(i) Applicants from Central Government / All India Services should be holding a post of the level of Director in Government of India or carrying equivalent scale of pay on the date of application.

(ii) Applicants from the Armed forces of the Union should be holding a post of the level of Brigadier in the Army or equivalent rank in Navy/Air Force on the date of application.

Applicants from State Public Sector Enterprises/ Private Sector should be working at Board level position or at least a post of the level immediately below the Board level on the date of application.

6. CONDITION OF IMMEDIATE ABSORPTION FOR CENTRAL GOVERNMENT OFFICERS

Central Government Officers, including those of the Armed Forces of the Union and the All India Services, will be eligible for consideration only on immediate absorption basis.

IV. DURATION OF APPOINTMENT

The appointment shall be for a period of five years from the date of joining or upto the date of superannuation or until further orders, whichever is earlier.

V. SUBMISSION OF APPLICATIONS

(d) CMDs/MDs/Functional Directors in State PSE: through the concerned Administrative Secretary and Cadre Controlling Authority, if any, of the State Government;

(e) Below Board level in SPSE: through the concerned SPSE;

(f) Private Sector: directly to the PESB.

2. Applicants from Private Sector must submit the following documents along with the application form:

(a) Annual Reports of the Company in which currently working for the 3 financial years preceding the calendar year in which the post is advertised (**please provide URL or attach/enclose copies**);

(b) Whether the company is listed or not; if yes, the documentary proof (**please provide URL or attach/enclose copies**);

(c) Evidence of working at Board level or at least a post of the level immediately below the Board

level;

(d) Self-attested copies of documents in support of age and qualifications;

(e) Relevant Jobs handled in the past with details.

VI. UNDERTAKING BY THE APPLICANT

An applicant has to give an undertaking as a part of the application that he/she will join the post, if selected. If an applicant does not give such undertaking, the application would be rejected.

1. For candidates from Central Government/Armed Forces of the Union/ All India Services

(a) The appointment is on immediate absorption basis.

(b) If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.

(c) Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.

2. For candidates from CPSE

a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

3. For candidates from SPSE/ Private Sector

a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.

b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.

4. In the above cases, no request for relaxation or otherwise would be entertained.
