3. An EMD of Rs. 5,000/- (Rupees Five Thousand Only) should be deposited with the tender in the form of an Account Payee Bank Draft / Pay Order from any Nationalized Bank in favour of **“Under Secretary (Cash), DoP&T, North Block, New Delhi”**.

General Terms & Conditions:


- 1) Bidder may inspect the items on the stipulated dates & time.
- 2) The items shall be sold to the highest bidder. The bids are invited for the lot (i.e. all the items contained in the list of obsolete/ unserviceable, Furniture/ Air-Conditioners/ Office equipment/ Scrap and other items as detailed in "Annexure-A") as a whole, and no bid would be accepted for any part for the same.
- 3) The successful bidder has to make full balance payment, after due adjustment of the EMD, in the form of Demand Draft in favour of "**Under Secretary (Cash), DoP&T, North Block, New Delhi**" within three days after confirmation, failing which the offer will be cancelled and the EMD shall stand forfeited. The EMD of unsuccessful bidders shall be returned within one month after the auction date, without any interest thereof.
- 4) List of items are given at "Annexure-A".
- 5) No item once disposed to the successful bidder shall be taken back by this department on any condition whatsoever.
- 6) The successful bidder will be required to lift all the items from the disposal site within three days after the payment of the bid amount. On failure to do so this office shall have the right to forfeit the entire amount of the bidder and dispose of the items through the alternate bidder. The successful bidder, on their own cost, will also be required to make their own arrangement of transport, labour, etc. for lifting the disposed items.
- 7) Quotation letter in the sealed envelope super subscribed "TENDER FOR DISPOSAL OF OBSOLETE/ UNSERVICEABLE FURNITURE/ AIR-CONDITIONERS/ OFFICE EQUIPMENTS/ SCRAP AND OTHER ITEMS" should be addressed to Shri Mohammad Jainuddin, Under Secretary, Public Enterprises Selection Board, 5th Floor, Block no. 14, CGO Complex, Lodhi Road, New Delhi-110003.
- 8) The quotation must reach on or before the due date and time otherwise it is liable to be rejected. Tenders received after the due date and time due to any reason whatsoever shall not be considered.
- 9) The financial bid should be given in both in figures and words. Any overwriting or erasing in the figures shall not be considered for acceptance of the rates offered by tenderer.
- 10) Department reserves the right to accept or reject any/ all quotations without assigning any reason whatsoever.



- 11) Each page of tender document should be signed by the bidder(s).
- 12) Incomplete and unsigned quotations are liable to be rejected. The bid is to be submitted for the entire lot, as mentioned in Sl. No.2 of general terms and conditions in the tender notice.
- 13) Bidders should enclose a copy of **PAN card / GST registration certificate** bearing **GST no.** The bidder should not be currently blacklisted or debarred by any Government Department/ Public Sector Undertaking/ Private Sector/ or any other Government agency. The declaration regarding this is to be submitted by the bidder along with the bid as per Annexure-C. Duly filled tender form as per Annexure-D should also be submitted in the said format.
- 14) The rates once quoted by the bidders shall be treated final and no request for revoking of the rates at any further stage will be entertained under any circumstance. Also, the EMD submitted in this case, will be forfeited.
- 15) The employees of Public Enterprises Selection Board and their relatives are not allowed to participate in the auction.
- 16) Bidder submit a "Bid Security Declaration" (Annexure-E) accepting that if they withdraw/ modify their bid during the period of validity etc., they will be suspended for the time as decided by the competent authority.
- 17) The department reserves the right to extend the bid to a specific time in case of no bidder participation with the approval of the competent authority.
