OFFICE MEMORANDUM

Subject:- Implementation of CoS decision taken in the meeting held on 11/11/2022 to discuss the issues related to PESB – nomination of a Nodal officer regarding.

It may be aware that PESB is in the process of reviewing the selection process, in this connection, a CoS meeting under the chairmanship of Cabinet Secretary was held on 11.11.2022 and decided among other reforms that officers in equivalent rank/ grade from Public Sector Banks (PSBs)/ Financial Institutions (FIs)/ Autonomous Bodies (ABs) etc. subject to fulfilling the eligibility criteria will also be considered as non-internal candidates.

2. In this connection, a GoI Resolution has been issued vide Gazette Notification No. 44011/2(s)/2022-Est.(B-II) dated 20.06.2023 amending the original GoI Resolution No. 27(21)-EO/86(CC) dated 03.03.1987 which states as under:-

The policy of the Government is to appoint through a fair and objective selection procedure outstanding professional managers to Level-I and Level-II posts and posts at any other level as may be decided by the Government from time to time. Government has also recognized the need to develop a cadre of professional managers within the public sector. Hence, unless markedly better candidates are available from outside, internal candidates, employed in the public sector enterprises, will be preferred for appointment to Board level posts. If internal candidates are not available, preference will be given to candidates working in other public sector enterprises, either in the same area of business or in other areas. Mobility of managerial personnel among public sector enterprises within the same sector or group, failing which mobility within the public sector as a whole will be encouraged, subject to certain limitations. *In special cases, Group 'A' officers of the Central Government including All India Services (AIS) & Armed Forces of India and officers in equivalent rank/ grade from Public Sector Banks/ Financial Institutions/ Autonomous Bodies, etc. subject to fulfilling the eligibility criteria will also be considered as non-internal candidates.*

"Candidates from State Public Sector Enterprises and the private sector subject to fulfilling the eligibility criteria will also be considered as non-internal candidates along with the candidates of other public sector enterprises for a period of five years with effect from 10.06.2021".

3. In light of the aforementioned amendment allowing thereby Group 'A' Officers of the Central Government including All India Services (AIS) & Armed Forces of India and officers in equivalent rank/ grade from Public Sector Banks/ Financial Institutions/ Autonomous Bodies, etc. PESB process entails receipt of application through proper channel. Accordingly, a Nodal Officer to verify and forward the application from such categories to PESB is required to be nominated by the concerned Administrative Ministry/ Department.
4. Further, PESB invites applications through on-line and is in the process of complete automation of selection process; therefore, the applications will be received on-line mode only. In this event, a Nodal Officer is compulsorily required to be registered in the PESB on-line application. Once a Nodal Officer is nominated, the nomination of Nodal Officer is to be informed to PESB for registration.
5. In view of the above, it will be appreciated that a Nodal Officer of appropriate rank for Ministry/ Department under your charge may kindly be nominated for forwarding the applications to PESB. Therefore, it is requested to nominate the Nodal Officer on priority in order to implement the above mentioned CoS decision.
