I. COMPANY PROFILE

Cochin Shipyard Ltd. (CSL) was incorporated under the Indian Companies Act, 1956. The main objective of the Company is to build and repair vessels to international standards and provide value added engineering services. The Company is with the administrative jurisdiction of Ministry of Ports, Shipping & Waterways. CSL is a Miniratna CPSE and was upgraded to Schedule 'A' with effect from 31.07.2023. The company went in for an IPO in August, 2017 and is presently listed in BSE and NSE.

Its Registered and Corporate offices are at Kochi, Kerala.

The Company employed 2162 regular employees (Executive - 515 and Non-Executive: 1647) as on 31.03.2024.

The authorized and paid up capital of the Company was Rs. 250 crores and 131.54 crores respectively as on 31.03.2024. The market capitalization of the Company as on 31.03.2024 was about Rs. 23,000 crores.

The Shareholding of the Government of India in the Company is 72.86% as on 31.03.2024.

II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Operations) is a member of Board of Directors and reports to Chairman and Managing Director and will be in charge of the Shipbuilding division of the Company. In this role, He/She will be responsible for furthering the Shipbuilding business and oversee Design and Engineering,

Material procurement, planning and Ship construction activities covering fabrication, outfitting, tests & commissioning, trials leading to delivery of ships meeting contractual time, cost and scope/quality requirements.

He/She will be responsible for large industrial workforce involved with ship production activities and will be required to ensure adherence to HSE norms and statutory provisions. He/She is expected to be instrumental for maintaining cordial industrial relations and motivation of a productive workforce within the division.

III. ELIGIBILITY

2. EMPLOYMENT STATUS:

Applicant should be an Engineering Graduate with good academic track record, preferably in Mechanical/ Electrical/ Marine or Naval Architecture discipline from a recognized university/institution.

The applicant should possess cumulative experience/ exposure for at least 5 years during the last 10 years in PSU/ Private Shipyard/ Indian Navy in Ship Building (Production, Planning)/Ship Design/ Overseeing of Ship Construction or Ship Repair / Business Development /Maintenance at Naval Headquarters (DFM)/ Naval Dockyards/ Naval Ship Repair Yard (NSRY).
