I. COMPANY PROFILE

Balmer Lawrie & Co. Limited (BLC) was incorporated under the Companies Act, 1956. By a scheme of arrangement, shares of Balmer Lawire were transferred to Balmer Lawrie Investment Ltd. (BLIL) by IBP, BLC is a multi product, multi location diversified business conglomerate operating through its various Strategic Business Units (SBUs) and Joint Venture Companies.

The Company is engaged in manufacturing of steel Barrels and Drums, Greases and Lubricants and Chemicals and providing services in the areas of travel and tours, logistics, container freight station, Warehousing and Distribution, Refinery and Oil field Services, Cold Chain etc. through its plants, sales offices, branch offices, technical services centers spread all over India. Today, BalmerLawrie has eight business units-Industrial Packaging Greases & Lubricants, Chemicals, Travel & Vacations, Logistics Services, Logistics Infrastructure, Cold Chain and Refinery Oil Field Services with offices spread across the country.

BLC is a Schedule 'B' Mini – ratna- I CPSE in Medium and Light Engineering sector with the administrative jurisdiction of Ministry of Petroleum & Natural Gas. The Company employed 863 regular employees (Executive – 521, non-unionized supervisors – 168 and non- executives – 174) as on 31.03.2024. its registered and corporate offices are located at Kolkata, West Bengal.

The Authorized and paid up share capital of the Company were Rs. 300 crores and Rs. 171 Crores respectively as on March 31, 2024. The shareholding of the BLIL in the company is 61.8%.

II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Services Business) is a member of the Board of Directors and reports to Chairman and Managing Director. He is responsible for providing direction and guidance to the Business under his charge i.e.; Corporate Travel Management and Holidays, Logistics Services and Logistics Infrastructure, Cold Chain, Environment Scanning, formulation and implementation of business strategies along with identification of appropriate technologies in the relevant areas.

2. EMPLOYMENT STATUS:

The applicant should be an Engineering Graduate / Graduate with MBA/PGDM with good academic record from a recognized university / institution.

4. EXPERIENCE:

The applicant should possess cumulative experience / exposure of at least 5 years during the last 10 years in service sector especially in Airlines / Shipping / Multi-modal transport / Logistics services / Logistic infrastructure / formulation and implementation of business strategies.

3. For candidates from SPSE/ Private Sector
